



Handout to Guardian with Fast Pass Tags

You will need your **fast pass tag** that you **MUST** have when dropping off and picking up your camper from Camp Metro. You are receiving 2 cards (per camper) for you and another authorized person you have included in your **CampDoc** authorizations. Anyone dropping off and picking up will also need their **driver's license** or other government-issued picture ID and be an authorized person in CampDoc.

Due to the safety protocols we have in place, GSSWT is exercising a contactless drop off and pick up at the curb for campers. There will be **no** exceptions. <u>Parent/guardian is required to always remain in the vehicle</u>. Girl may be dropped off at either location as early as 7 a.m. and needs to be picked up no later than 6 p.m. each day. Camp activities take place from 9 a.m. – 4 p.m. each day.

The following protocols will be in place:

Drop-off 1. Always follow posted signs and staff directions. 2. Camper/parent are to remain inside vehicle. 3. Staff will greet and ask camper's name. 4. Screening questions will be asked. Only campers who pass the screening will be allowed to proceed. 5. If: - Camper is cleared, staff will scan the fast pass tag, verify ID and authorization to check camper into camp If camper does not clear screening check, parent/guardian will be asked to take camper home. 6. Parent/guardian will exit parking lot.	Drop-off 1. Always follow posted signs and staff directions. 2. Camper/parent are to remain inside vehicle. 3. Staff will greet and ask camper's name. 4. Parent/guardian will exit parking lot. NOTE: Camper must arrive by 8 a.m., no exceptions.
