Opt-out of Rewards GUIDELINES

This initiative is available to Girl Scout **Junior, Cadette, Senior, and Ambassador troops ONLY** (multi-level troops with Girl Scout Daisies or Brownies are **NOT** eligible).

Junior, Cadette, Senior, and Ambassador troops (or combination of, without Daisies or Brownies) with a minimum troop PGA of \$320 may opt out of ALL rewards and receive an additional 7% of all products sold for the 2025 Fall Product Program. Girls will still receive ALL earned patches.

A fully completed and signed form **MUST** be turned in to the Product Program department no later than 5 p.m., Mon., Oct. 27. Forms submitted after this date will be accepted on a case-by-case basis.

Rules & The Fine Print

- Entire troop **MUST** vote on this option. ALL registered girls in the troop **MUST** be listed and included in the vote, signature, etc.—**EVEN** if that girl did not sell fall products during the 2025 season.
- Troop must have a minimum troop PGA of \$320. Troop PGA is listed on the Summary Report in M2.
- Multi-level troops with Daisies and Brownies are **NOT** eligible.
- The decision to opt-out will be determined by majority rule.
- Girls selling will still receive all earned patches.
- The Troop Leader and Troop Nut Manager must sign this form as consent of the troop's decision to opt out of earning girl rewards.
- This form must be submitted to the council by 5 p.m., Mon., Oct. 27. **LATE SUBMISSIONS** may be submitted, but not necessarily approved.
- Troops that toggle on the reward opt-out option in M2 without completing this form will not be eligible. Council will toggle on the reward opt-out function in M2 for the troops that have met the troop per girl average requirement and submitted a complete opt-out form.
- Use only one form per troop. If you are a Troop Leader and Troop Nut Manager for multiple troops, you must complete this form for **each** troop.
- *Troops with delinquent accounts—troop or parent—will not be applicable for this initiative.*
- *Troops having issues with the ACH process or submitting an ACH adjustment may not be eligible for this initiative.*
- *Troops not in compliance with council-approved troop bank accounts may not be applicable for this initiative.*
- These additional proceeds will be calculated after the fall program audit is completed and will be submitted to the troops in an additional transaction (outside of receiving their original proceeds) no later than the end of December. If troops submit delinquent accounts with end-of-program paperwork—troop or parent—additional proceeds will **NOT** be given.
- This initiative is not available to IRGs as those funds are pooled at the council.
